

1. Force majeure, strike and lockout in and outside of Sweden, major machinery breakdown, energy failure, war or other warfare conditions in Sweden and in other countries, no deliveries or delay of raw material or other similar delivery problems, does justify BEWi according to own judgement, to either partly cancel the order or to postpone the delivery until further notice. A cancellation of the order or postponement of the delivery does not apply the obligation of compensating any loss, which might have been a consequence of this
2. Materials and goods, which we, at the time of the above-mentioned incident would have in stock, we commit ourselves entirely or partly to comply/fulfill current orders, according to our own judgment. Should the value of the SEK change, or should the above mentioned alone cause that the fulfillment of the agreement to become more expensive on our part, we not alone are engaged to carry out the order, in the event that the buyer declares to compensate BEWi for any additional costs, which might have been.
3. The customer may not put in a claim in case BEWi exceeds the time of delivery, such as may arise.
4. The right to quantity deviation of $\pm 10\%$ to be accounted for
5. There is no guarantee for minor color deviation
6. Unless described in the contract, recycled material may be contained in the finished products
7. Drawings, design tests or other material are the property of BEWi, and BEWi preserves every right, hereunder immaterial rights, for the material, which may not, unless a preceding written agreement has been signed with BEWi, be copied, published, handed over or in any other way be exploited in defiance with BEWi rights
8. Moulds, which BEWi manufacture in connection with producing new product, are the property of BEWi even though the expenses for manufacturing the moulds partially are paid by the purchaser. The purchaser acquires the production rights for the tool and BEWi commit to keep the moulds in repair and ready for production at all times
9. Potential complaints must, in order to be valid, be sent to aftersales@bewi.com immediately after receiving the goods. Defective goods will be exchanged or repaired within a reasonable respite, but BEWi is not obliged to pay compensation. By judgment whether a good is in accordance with the terms of the contract, it is decisive if it corresponds with the customer and the customers approved samples
10. Unless an agreement concerning third party liability has been excluded, in regard to the law concerning product liability, our responsibility for the damaged good, which the sold good may have caused, is hereby limited:

We are only responsible for personal injury, if it can be demonstrated, that the defect or neglect is committed by either us or our BEWi employees.

We are not reliable for damages on real or personal property, which occur while the delivery is in the possession of the buyer. We are neither responsible for products, which have been manufactured by the purchaser or on products where these incur. Moreover, we are responsible for damaged caused on real or personal property on the same conditions as for personal damages. We are not responsible for loss of operations, loss of profits, loss of earnings or other indirect loss
11. An increase in prices is subject to change, provided that the price on raw material increases by 5% or more from the time of confirmation of order to the day of delivery
12. The products are produced under the terms of the legislation in force in regard to material or articles specified for being in contact with foods. Further information can be obtained via www.bewi.com
13. We maintain the right to deliver your products 2 days prior to the date of delivery
14. For orders below 5000 SEK, an expedition cost of 500 SEK will be charged
15. Fee for late change of order will be charged if change occurs less than 7 days before delivery date, 295 SEK
16. Orders that are not collected on the scheduled date will be charged with a storage fee of SEK 500 / day. Orders that require more storage space is charged with the actual cost
17. Offer is valid for 30 days from the date
18. The customer is obliged to check the contents of the order confirmation and promptly, before the delivery, inform BEWi any amendments or objections. The order confirmation will be considered as a binding document.
